It is funded by the Welsh Government and the funding is now administered by Carmarthenshire County Council. A local company have won the tender to run the service, unfortunately the bus they have been using previously is no longer available as it needs work doing to it. Another bus has been sought, whilst Carmarthenshire County Council and the local company have signed the contract for the new bus, Welsh Government have yet to do so. This is delaying the process of having the service up and running.
