CC Llangrannog wants to draw your attention to the following facts :

The application for change of use to B&B accommodation contravenes the previous clause issued for both the original application dated 11/10/22 and the most recent application dated 9/2/24;

'The annexed living accommodation hereby approved shall be incidental to the uses of the main dwelling and shall not be occupied at any time as a separate and un-associated unit of permanent accommodation or used in conjunction with ANY commercial venture.'

The reason given, based on Highways & Environmental Services recommendations was :

'To secure the use of the proposed development as approved and in the interest of road safety'.

The wooden cabins were permitted to be located on the Llys y Nant site for family use only although the dwelling was in a coastal area (LU14).

In the interests of road safety, the application claims that there is room for 3 or 4 cars on site. In fact, there is room for one car on site and there is a layby for one other car in front of dwelling on the road (B4321).

There is no right to park cars overnight at the nearest Public Car Park.

CC Llangrannog opposes the application for the reasons listed above.
