Pentref sydd yng nghanol twristiaeth Ceredigion yw Llangrannog a dymuna'r Cyngor Cymuned tynnu sylw'r Cyngor Sir yr effaith y bydd cau'r toiledau yn ei gael ar ddyfarnu'r Faner Las gan mae un o'r maenu prawf o hynny yw cael nifer digonol o doiledau. Pe bai'r Cyngor Sir yn cau'r toiledau byddai hyn hefyd yn golygu na fyddai toiled mynediad anabl yn y pentref. Mae Gwersyll yr Urdd Llangrannog yn ganolfan breswyl leol sy'n rhoi cyfleoedd i filoedd o blant grwydro rhan brydferth o Geredigion, byddai cau'r toiledau cyhoeddus hefyd yn cael effaith andwyol ar y gweithgareddau a ddarperir gan y Gwersyll lawr yn y pentref.

108.02 Future of Llangrannog toilets

Following a lengthy discussion a unanimous vote was agreed the Llangrannog Community Council are not in the position to take over the toilets in Llangrannog. Clerk to write an email to Property Services outlining the following;

A number of concerns were raised such as who would employ the person that would clean? What would happen if this person was not in work due to illness? Who would be responsible for dealing with any issues that arise? There was also the additional cost of the public liability and any major building maintenance e.g. roof repairs, replacement windows etc.

The above are all issues that can be addressed by the County Council as it already has staff employed that would do all of this.

In order for Llangrannog Community Council to take on the toilets it would need to look at nearly doubling its current precept. The Community Council don't want the toilets to be closed as we feel the Local Authority would be best placed to maintain the public toilets.

Llangrannog is a village at the centre of the tourism in Ceredigion and the Community Council wishes to bring to the County Council's attention the impact closing the toilets will have on awarding of the Blue Flag as a criterion of that is to have an adequate number of toilets. Should the County Council close the toilets this would also mean that there would be no disabled access toilet in the village. Gwersyll yr Urdd Llangrannog is a local residential centre that provides thousands of children with opportunities to explore a beautiful part of Ceredigion, closing the public toilets would also have a detrimental effect on the activities that are provided by the Gwersyll down in the village.
