Darperir rhestr o'ch cynghorwyr lleol uchod.

Nid yw'r cynghorwyr yn cynrychioli unrhyw blaid wleidyddol. Am y rhan helaethaf o'r flwyddyn mae deg o gynghorwyr wedi bod yn weithredol ar Gyngor Cymuned Llangrannog, ar hyn o bryd mae gan y Cyngor wyth Cynghorydd gweithredol. Cânt eu hethol bob pedair blynedd, neu eu cyfethol rhwng etholiadau.

Cyflogir Clerc rhan-amser i ymdrin â threfniadau cyfarfodydd, â threfniadau gohebiaeth ac â threfniadaeth ariannol.

Mae lle i unarddeg o gynghorwyr ar y Cyngor. Mae 669 o etholwyr yn byw yn ardal y Cyngor (2024).

Structure of the Council

A list of your local councillors is provided above.

The councillors do not represent any political party. For most of the year ten councillors have been active on Llangrannog Community Council, currently the Council has eight active Councillors. They are elected every four years, or co-opted between elections.

A part-time Clerk is employed to deal with meeting arrangements, correspondence arrangements and financial arrangements.

There is room for eleven councillors on the Council. 669 electors live in the Council area (2024).

Sut mae'r Cyngor yn gweithio?

Bydd unrhyw waith a wneir gan y Cyngor yn cael ei weithredu yn dilyn penderfyniadau a wneir mewn cyfarfodydd agored. Telir am unrhyw waith gydag arian cyhoeddus y mae'r Cyngor yn ei dderbyn trwy godi archebiad (praesept), sef yr arian a godir gan y Cyngor yn fisol oddi wrth drigolion y gymuned, a gesglir fel rhan o'r Dreth Cyngor a bennir gan Gyngor Sir Ceredigion.

How does the Council work?

Any work done by the Council will be implemented following decisions made at open meetings. Any work is paid for with public funds received by the Council by charging a precept, which is the money raised by the Council monthly from residents of the community, collected as part of Council Tax determined by Ceredigion County Council.

Beth yw archebiant (praesept) y Cyngor?

Cyfanswm archebiant 2024-2025 oedd £10,500.00. Mae'r archebiant yn cael ei godi i ariannu cyfrifoldebau'r Cyngor Cymuned sydd yn cynnwys gwariant ar dorri gwair, cynnal a Cae'r Neuadd, cynnal a chadw diffibriliwr ac i gyfrannu i sefydliadau lleol.

What is the Council's precept?

The total booking for 2024-2025 was £10,500.00. The precept is raised to fund the Community Council's responsibilities which include expenditure on mowing grass, maintenance of the field by the Hall, defibrillator maintenance and to contribute to local organisations.

Cyfarfod Blynyddol

Mae'r cyfarfod blynyddol yn rhwymedigaeth cyfreithiol fel y nodir yn Neddf Llywodraeth Leol 1972. Rhaid cynnal y cyfarfodydd blynyddol ym mis Mai. Y Cyngor sy'n penderfynu ar y dyddiad. Yr eitem gyntaf ar yr agenda yw ethol Cadeirydd y Cyngor Cymuned am y deuddeg mis nesaf.

Annual Meeting

The annual meeting is a legal obligation as set out in the Local Government Act 1972. The annual meetings must be held in May. The date is decided by the Council. The first item on the agenda is the election of the Chair of the Community Council for the next twelve months.

Mae'r cynghorwyr wedi dechrau dylen raglen hyfforddiant ar gynllunio, a wedi cael ei ddarparu gan Gymorth Cynllunio. Wedyn cafwyd Hyfforddiant Cod Ymddygiad gan Gwasanaeth Democrataidd a Safonau, Cyngor Sir Ceredigion.

Councillor Training Programme

A training plan is in place to ensure that all councillors are fully aware of the processes and responsibilities of members and the Council. Councillors have started a training programme on planning, which has been delivered by Planning Aid Wales. Code of Conduct Training was then provided by Ceredigion County Council's Democratic and Standards Committee.
